## **VENDOR REQUIREMENTS**

COMPLIANCE IS MANDATORY FOR ALL PARTICIPATING VENDORS. RAIN OR SHINE EVENT.

BOOTH SPACE: 10'x10' space ONLY. MUST BRING YOUR OWN tent, 2 x 6' tables, and 4 chairs.

Set up begins at 1:00PM. Fire Marshall and Health Department inspection between 3:00PM to 5:00PM.

[Tent must be Fire retardant and NFPA701 Flame Certified or CPAI-84 Flame retardant seal marked and have certification on site or on the tent]. Set up 4-hour before and clean up by 2-hour after the event.

**ELECTRICAL & SPECIAL AMUSEMENT DEVICE PERMITS**. Bring your own generator. **Generator 6500 watts or greater** and/or the installation of temporary electrical wiring, circuits, and equipment may require an electrical permit and inspection. Call Fairfax County 703-222-0801 option 2 for further assistance.

**Liquefied Petroleum Gas (LPG) / PROPANE.** An operational permit (i.e., FPCP) is required for the handling, storage, and use of LPG outside **where the quantity is greater than 10 gallons** aggregate; e.g. more than two, twenty pound cylinders. **GRILLS WITH OPEN FLAMES MUST BE OUTSIDE THE TENT.** Propane Tank exchange at the Home Depot contains approximately 15 lbs. propane. [ex. 8.34 lbs = 1 gallon]

**Equipment: Food Vendors (onsite cooking)** Bring your own **propane tanks** (with current hydro date 12 years from the date manufactured or 5 years from last requalification); Propane tank **hose must be at least 10'-0"** and tank must be secured with milk crates; **Fire extinguishers** (with current inspection **tag validated within past 12 months**), and commercial use extension cords (20 ft./U.L. listed and rated for outdoor use).

**Supplies:** Food Vendors must bring their own trash cans, liner, water, ice, rinsing station, and compostable ware for serving food.

## Application Deadline: APRIL 15th, 2024, Monday.

Menu: KORUS RESERVES THE RIGHT TO LIMIT NUMBER OF ITEMS FOR SALE AND FROM SELLING DUPLICATE ITEMS.

Beverages: Alcoholic beverage sales are PROHIBITED. Only non-alcoholic beverages are allowed.

**Setup / Teardown:** Setup starts at 1:00PM 5/3 Friday and must be down by 9PM 5/5, Sunday. Vendor's Booth space shall be confirmed by 4/15/2024.

**Parking:** OPEN Parking.

Signage: TWO (2) self-made signs are allowed on Tents. Menu items and pricing must be displayed.

**Insurance:** ALL Vendors must provide a copy of the Certificate of Insurance naming KAGW as additional insured and post it on tent with permit.

Proceeds & Sales tax: VENDORS keep all sales proceeds, and pay VA sales tax.

**Refund:** Application fee is Non-refundable. This is an outdoor event, Rain or Shine!

KORUS reserves the right to refuse ANY application.

Trash and Oil: Bring your own trash containers. Dump your own trash at a designated Trash dumpster, located next to SPA store side street. DO NOT dispose used cooking oil or rinsing water in the dumpster! You will be penalized!

Relocation: Relocating/trading assigned booth spaces is NOT allowed without prior written consent from KORUS.

DO NOT extend beyond your space.

Permit: FOOD Vendors MUST obtain a Temporary Food Permit from the Fairfax County Health Department and may take up to 30 days. Permits must be displayed for an inspection.

**Inspections:** The Fairfax County Fire Marshall and the Health Department will conduct on-site inspections to check permits and ensure that guidelines/regulations are followed.

Failure to meet these guidelines/regulations will lead to removal from the event with NO refund.
